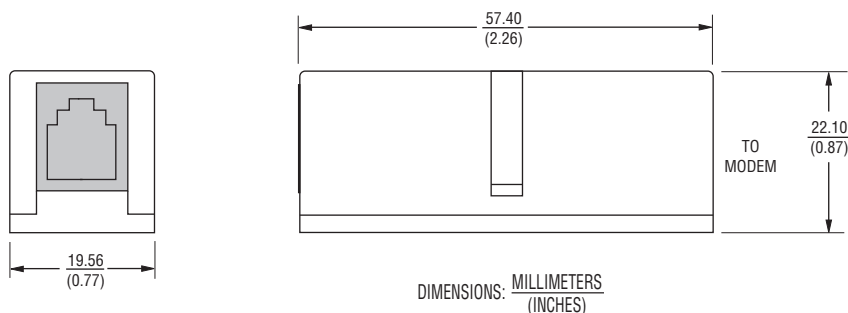
Model 2391 Isolated Dongle

Ungrounded communications circuits at the customer premise can pose a damage risk to equipment due to lightning and other transient events. Standard RJ11 connections are used for the input and output connections.
